The Puget Sound Emergency Radio Network (PSERN) Project is reaching out to you because our records indicate you are the point of contact for the public safety DAS (Distributed Antenna System) compliance of the following property in King County, Washington:

As we have been announcing for the past two years, when fire, law enforcement, and other first responders in King County begin using the new PSERN digital emergency communications radio system, properties with public safety DAS will also need to make a change. This message is to provide you with your Fire Marshal-designated property Priority Level and to offer you an overview of what to expect in the [DAS Migration Process](#) that your property is required to follow to become compliant with [public safety and usage of radio frequency regulations](#) related to PSERN.

Property Priority Level, DAS Shutdown Date, and Migration Process

The priority level designation is made by the local Fire Marshal. If you have any questions or concerns about your property's designation, please contact your local Fire Marshal. PSERN cannot change your priority level designation. This level will determine the timing of how and when you need to participate in the DAS activities related to PSERN. DAS Migration Process Upcoming Activities

To support properties with public safety DAS in King County to prepare for the DAS Migration Process, the PSERN Project will be hosting a **virtual Town Hall meeting for property representatives and DAS vendors on Wednesday, January 4, 2023, at 10:00 a.m.** A calendar request with meeting details will be sent to you shortly. This Town Hall will be recorded and posted in the DAS Migration Process section of the website in early January. Please note that the Q&A portion will not be recorded, so please plan to attend the Town Hall to ask questions. Additionally, the PSERN Project will continue to send you countdown reminders as we move closer to your assigned DAS Shutdown Date. **It is your property's responsibility to become compliant with [public safety and usage of radio frequency regulations](#) related to PSERN.**

PREPARE FOR DAS MIGRATION: If you have not already done so, please [hire a DAS Vendor](#) to support disabling your public safety DAS, assessing your DAS, and taking necessary steps for your property to become compliant with PSERN. There are a limited number of vendors, so it is important to have your DAS assessed as soon as possible to not impact becoming compliant with PSERN.
