5. Action Register Review – Meeting Chair 2:33 – 2:34 p.m.

No updates to the two open action items in progress.

6. Executive Director Report – Mike Webb

2:34 – 2:44 p.m.

Mike Webb provided an update on the PSERN Operator activities since the February meeting.

PERC has certified card check results in favor of the IBEW 77 petition for representation.

An RFQ was posted on the procurement portal Bonfire for an engineering consultant; a second RFQ for an electrical design consultant primarily for the Maloney power line will be posted by Feb 23.

The Operations Committee has held two meetings to date. A police chief representative position is vacant. Official notification confirming their representatives is pending from EPSCA, Seattle, and Fire. Chief Scoggins provided confirmation of Assistant Chief Chris Lombard as the City of Seattle's representative.

On-boarding continues for Issaquah Public Works and KC Water District 40. Bothell PD dispatch is decommissioned, and consoles being redeployed.

Radio reprogramming and DAS migration are continuing. PSERN has dealt with three incidents of harmful interference caused by DAS systems, but no service impacts.

Radio site leases and subleases are in progress and a status will be brought to the Board in April.

7. Preliminary 2023 Year-End Financials – Tracy Plouse

2:44 – 2:49 p.m.

Annual financial reports are due to the State Auditor by May 30. The final financial statements are planned to be presented at the April meeting. Preliminary operating expenses for 2023 are \$2.2M and will likely change as transactions are reconciled. A preliminary breakdown of cash flow, revenues, and expenses was provided and is detailed in the staff report.

8. User Agency Service Fee Invoicing Procedure – Mike Webb

2:49 – 3:03 p.m.

The 2024 budget used 2021 radio inventories to set service fees for invoicing in 1Q 2024. Since then, there have been changes to the number of radios due to agencies adding/reducing. A procedure for adjustments to quantities is required. PSERN outlined three issues that need to be addressed and a proposed procedure for the Board's comment or feedback:

- Confirm which radios and quantities are included in rate calculations.
- How should the Operator confirm quantities of radios and consoles for service fee rate calculations?
- Should the Operator manage changes in radio and console quantities outside of the budget process?

PSERN proposed procedures for the radio quantities and service rates, and a timeline for radio quantity updates, was shared and is provided in the presentation.

Kurt Triplett expressed concern about trying to manage changes throughout the year would be an administrative burden when rates need to stay stable.

Mike Webb responded that agencies will expect to be able to make changes (additions or reductions) and, a quarterly reconcile will not be overly burdensome. As there are still some significant additions occurring this year by certain agencies, PSERN should be trying to capture the revenue for those additions. When quantities stabilize, we could consider a yearly reconciliation/update. PSERN will proceed and may revisit it after a year.

#### **SUMMARY:**

This report provides a summary of the activities of the PSERN Operator (PSERN) since the last report to the Board at the February 22, 2024, meeting.

#### **DISCUSSION:**

#### **PSERN Operator Staffing**

- PSERN Operator staffing currently stands at 22 out of 24 authorized in the 2024 budget:
  - o One member of the Technical Operations team retired in March.
  - o Recruitment to backfill this position (System Administrator) is underway.
  - The vacant position the finance/admin team is being filled by temporary staff in the short term.
- Discussions are being held with PERC and IBEW local 77 to organize training for the respective bargaining committees and otherwise prepare for the commencement of bargaining:
  - o To date, no timeline has been established.

#### <u>Financial</u>

- Payment of PSERN service fees for the 1<sup>st</sup> quarter of 2024 is nearly complete and as of April 15<sup>th</sup>, \$2.179M out of a total of \$2.313M in 1<sup>st</sup> quarter fees have been received (94%).
- 13 invoices out of approximately 120 issued for 1Q 2024 service fees remain unpaid (most are small amounts).
- 2<sup>nd</sup> quarter 2024 invoices were distributed on April 1<sup>st</sup>, along with a letter that describes how agency changes to radio quantities will be handled:
  - o Agencies have also been requested to provide a forecast of their radio quantities in 2025.
- A report on preliminary 2023 financial results has been prepared and will be discussed in agenda item
   7:
  - o This report includes the valuation of all capital assets received from King County.
  - o Financial results need to be submitted to the State Auditor by May 30<sup>th</sup>.
- A report on capital projects and funding requirements has been prepared and will be discussed in agenda item 9:
  - This includes a motion to authorize proceeding with the required procurement activity for

2024 projects.

#### **Procurement Activity**

- A Request for Qualifications (RFQ) for Architecture and Engineering (A&E) services to support RF and Microwave engineering work closed on March 28th and 6 submissions were received:
  - The submissions are currently being evaluated and the target for executing master service agreements is mid-May.
  - The initial Work Order to be executed under these service agreements will be for the first phase of in-building coverage assessment work (for which \$1M in funding has been set aside).
  - The intent is that the newly formed Technical Working Group, reporting to the Operations Committee, will provide user agency oversight and guidance for this work.
- A Request for Qualifications (RFQ) for A&E consultants to assess and define improvements to site
  power at Maloney/Sobieski, prior to the powerline replacement, is currently posted on the MRSC
  Bonfire portal and closes April 29th.
  - o This work is further discussed in agenda item 9.

#### **PSERN Operations Committee**

- The PSERN Operations Committee met on March 11<sup>th</sup> and April 9th.
- 8 committee members out of the 9 members identified in the bylaws are in place:
  - The King County Police Chiefs and Sheriff's Association has been requested to identify an individual to fill the vacant position.
- The Terms of Reference for a Technical Working Group, reporting to the Operations Committee, was approved on March 11<sup>th</sup>:
  - Agencies have been requested to provide members/participants in the working group.

#### Stakeholder Engagement Strategy and Website Evolution

- The new PSERN Operator website (psern.org) was launched on April 3<sup>rd</sup>:
  - Work is underway to review and update some of the images on the new site.

#### **PSERN User Agency Updates**

Redeployment of Bothell Police dispatch consoles is underway.

#### **Operational Status and Updates**

- PSERN staff are working on the removal of legacy (KCERCS) system programming from all PSERN radios, and making certain other high priority updates:
  - Total codeplugs to be updated/modified: ~500
  - Codeplugs in progress: 84
  - Number of codeplugs completed: 102

- DAS migrations are continuing:
  - o As of April 15, 435 out of an estimated 936 (46.5%) systems across the County have migrated.
  - PSERN is providing information on status of specific buildings to user agencies encountering in-building coverage issues.
- PSERN continues to respond to incidents involving harmful interference caused by Distributed Antenna Systems (DAS) installed by property owners to enhance in-building coverage.
  - These are primarily occurring in downtown Seattle and Bellevue, along with the Kirkland Justice Center.
  - New test equipment and staff training has been rolled out to assist in locating and mitigating harmful interference.

#### Radio Site Leases and Subleases

- All lease agreements between King County and the PSERN Operator have now been executed:
  - o No outstanding items remain from the Transfer Agreement execution and closing.
- PSERN is currently in discussions with the following organizations regarding new sub-leases:
  - o T-Mobile (up to 3 sites)
  - Verizon (2 sites)
  - Dish Networks (1 additional site Bellevue Station 9)
  - Microwave-only carriers:
    - McKay Brothers (up to 3 sites)
    - Pioneer Wireless (up to 3 sites)
    - RSN (up to 3 sites)
    - Startouch (backhaul provider for T-Mobile at Grass Mountain).
  - o Pano AI (4 additional sites in the Highway 410 corridor for wildfire detection).
  - NOAA/National Weather Service (1 site in Highway 2 corridor for Weather Radio).
- The renewal of the sub-lease with WSDOT at Cambridge will be executed shortly.
- A report on the status of current and future sub-leases will be discussed in agenda item 10.

#### **Upcoming Board Meeting Topics**

- Topics expected to be brought forward over the next 3 board meetings include the following:
  - o May 2024:
    - Final 2023 financial results.
    - Preliminary draft of 2025 operating budget.
    - Approval of public records policy.
  - June 2024 (Special Meeting):

- Approval of 2025 operating budget and service fees.
- o July 2024
  - 2Q 2024 financial results.
- These topics are in addition to the regular standing items, including the Consent Agenda, Action Item Log, Executive Director's report, and any approvals that may be required.
- Approvals to commence the engineering work discussed above (coverage assessment and Maloney/Sobieski power system assessment) will be brought forward over the next two meetings.
- Please note that a Special Meeting will be required in June for the approval of the 2025 budget.

#### **SUMMARY:**

This report provides an update on PSERN Operator preliminary financial results for the first quarter of 2024. A discussion of the results and anticipated amounts for the remainder of the year are provided.

#### **BACKGROUND:**

With FSA completed and the PSERN Transfer Agreement closed, the PSERN Operator is now operational and collecting revenue as of January 1, 2024. Operating expenses during 2024 are funded from service fees as defined in the 2024 operating budget that was approved in June 2023.

PSERN staff have been reviewing expenditures that occurred in the last half of 2023 and the first quarter of 2024 to ensure they have been appropriately classified as either startup expenses (one-time) or ongoing operating expenses. This work is mostly complete however further review may result in some additional adjustments in the coming weeks.

#### **DISCUSSION/ANALYSIS:**

#### Spending Year-to-Date (1Q 2024)

Table 1 below provides a summary of 2024 operating results to. Appendix A provides a detailed view of the Q1 results and comparison to budget.

The following notes apply to the table above. The categories are taken from the annual budget that was adopted and are categorized to be used for calculating annual user fees. Interest Revenue percentage-to-date is higher than the annual budgeted amount. Interest revenue will be allocated to the set-aside funds in future periods.

1. Salaries and Benefits for year-to-date are less than budgeted due staff vacancies and benefits amounts. At the time of the budget adoption the cost of providing benefits similar to King County was estimated, as the benefits providers were not selected until the fall of 2023.

<sup>&</sup>lt;sup>1</sup> Interest revenue is presented as a direct offset to expenditures as adopted in the 2024 budget. This offset is used in user fee calculations.

<sup>&</sup>lt;sup>2</sup> Sublease revenue is presented as a direct offset to expenditures as adopted in the 2024 budget. This offset is used in user fee calculations.

- 2. Employee-Related costs percentage overall exceeds the 25% year to date budgeted percentage due to the addition of a vehicle fuel line item that was omitted in the adopted budget.
- 3. Premise Costs includes all expenses for the Kent Corporate Office. The amount in the insurance line item is for the entire year and is not prorated by quarter. Insurance costs increased after the adoption of the budget due to the additional coverage required to insure the property stored in the Kent warehouse.
- 4. Corporate Technology Costs encompasses the costs to provide IT to employees and is separate from IT costs associated with network operations and radio site costs. Software costs for Quarter 1 include the amount paid for annual licenses and are not prorated. IT Network Services cost is over budget due to the increase in services required to meet the IT needs.
- 5. Professional Services includes consulting and legal services. While there is a minimal amount expended to date in this category it is expected that there will be additional expenses in 2024 for legal due to labor negotiations and consulting for procurement of engineering services and capital improvements.
- 6. Radio Site Costs includes insurance expense for the entire year, which was not prorated for the report. Site utility expense was estimated at the time of budget adoption and will need to be recalculated using year-to-date actual amounts for the 2025 budget adoption. There are several line items (radio site maintenance expenses) for which there are no expenditures to date. These costs are expected to be incurred later in the year as sites become accessible.
- 7. Network Technology Costs for budget adoption were also estimated with the absence of any operating history and will be reassessed for the 2025 budget.

#### **Cash Position**

The PSERN Operator's cash as of April 17, 2024 is summarized in Table 2. The Operator's accounting fund type, as mandated by GASB, is a proprietary enterprise fund. This type of fund cannot have restricted cash unless it is a condition placed on the cash by an external agency. The cash has been reported using the term "Set-Aside" to designate funds that are required to be used for specific expenditures.

The Start-Up expenditures in 2024 are mostly comprised of one-time set up costs for items and services required to commence operations. It is expected that the remainder of the Start-Up funds will be expended in the same manner.

The table shows that the Cash Available for Operations is in a slight deficit for Q1 2024. However, we have not considered the Cashflow Set-Aside (net) in this calculation. Please note that a significant percentage of the annual lease payments were made in January 2024 as well as large insurance payments that cover the entire fiscal year.

The total of Start-Up expenditures as of December 31, 2023 was presented at the January 2024 board meeting as \$2,716,147, and this report summary shows \$2,541,314. The difference is due to reclassification of expenditures and accrual corrections for prepaid insurance and other 2024 expenditures that were misclassified as Start-Up expenditures.

This deficit has been covered through the partial use of Start-Up Cashflow Funds to Operator (\$500K). This cash deficit is expected to disappear as 2Q 2024 revenues are collected.

#### **CONCLUSION:**

This report provides an update on expenditures for the first quarter of 2024, including a calculation of the percentage of the budget expended compared to the percentage of the fiscal year that has surpassed. A summary of the Operator's cash and the designated set-asides as of April 17, 2024, has also been provided.

#### **SUMMARY:**

This report provides a preliminary view of the PSERN Operator's 2023 fiscal year financial statements as of December 31, 2023. The final statements, including Management Discussion and Analysis (MD&A) will be presented at the May meeting prior to filing with the State Auditor's Office before the end of May.

#### **BACKGROUND:**

Per the Washington State Auditor's Office BARS reporting requirements, annual reports are to be certified and filed with the State Auditor's Office within 150 days after the close of each fiscal year. The BARS GAAP manual states that "the legal reporting requirements prescribed by the State Auditor's Office for local governments in Washington State are consistent with national standards of financial reporting prescribed by the GASB". These requirements for GAAP governments are as follows:

- 1. Basic Financial Statements, including notes to financial statements.
- 2. Required Supplementary Information (including MD&A)
- 3. Supplemental Schedules

#### **DISCUSSION/ANALYSIS:**

This report provides preliminary financial statements, including the Statement of Net Position, the Statement of Revenues, Expenses and Changes in Net Position and the Statement of Cash Flows.

The <u>Statement of Net Position</u> provides a record, or snapshot, of the assets and liabilities at the close of the year. The net difference between the PSERN Operator's assets and liabilities is shown as the PSERN Operator's net position. Net position is further broken down into the separate categories to show the portion of net position that is invested in net capital assets and unrestricted net position. For the twelve months ending December 31, 2023, the total net position of the PSERN Operator was \$152,716,519. The net increase from 2023 to 2024 was \$149,905,908.

#### Assets

Other current assets include prepaid expenses, interest receivable, and inventories. The prepaid expenses were primarily payments for insurance for which the expenses will be recognized in 2024. The inventories include radios transferred from the Project in December 2023 that will be held by the Operator as inventory. The interest receivable is December 2023 interest on cash on deposit with King County, which will be paid in January 2024.

On September 1, 2022, the PSERN Operator implemented GASB 87 (Statement). This Statement increases the usefulness of governments' financial statements by requiring recognition of certain lease assets and liabilities for leases that previously were classified as operating leases.

In December 2023, the PSERN Operator assumed radio site leases from both King County and Motorola as part of the transfer agreement. The asset, liability, amortization, and interest were calculated using term and rate escalation information from the lease documents. These amounts are still be recalculated as more information becomes available and final amounts will be presented at the May board meeting.

The Operator also assumed subleases from King County in December 2023. GASB 87 requires that subleases be reported using the same rules as leases. Sublease asset, deferred inflow of resources, interest and subleases receivable accounts will be created in the general ledger. Complete information is not available to date and will be presented at the May meeting.

Subscription Based Information Technology Arrangements (SBITAs) are accounted for using GASB 96 (Statement). This was effective January 1, 2023, and SBITA asset, liability, amortization, and interest amounts are reported.

Capital Assets increased by \$144,210,912 in 2023. Table 2 summarizes the capital assets of the Operator on December 31, 2023. The majority of the capital assets were acquired by the Operator as a result of the December 2023 transfer agreement with King County.

PSERN staff have estimated the value of the capital assets acquired based on the initial cost and the dates in which assets were placed into operational service. Net asset values have been entered into our depreciation schedule according to our Capital Asset Policy. Certain expenditures that were capitalized by the PSERN Project, such as consulting and project personnel costs, were not included in the calculations as they do not represent a cost that would be included in the assets' replacement.

#### **Liabilities**

Liabilities as of December 31, 2023, total \$20,588,515. Accounts Payable in the amount of \$387,660 and Due to Other Governments (amount owed to KCIT for contracted services) in the amount of \$100,922 are for 2023 expenditures that will be paid in 2024. The remainder of the liabilities represent the liability side of the GASB 86 and GASB 97 calculations as discussed in the Asset section.

The <u>Statement of Revenues</u>, <u>Expenses and Changes in Net Position</u> presents the results of the business activities over the course of the fiscal year and the resulting change in net position of the PSERN Operator.

There were no operating revenues for the fiscal year 2023. As directed by GASB guidelines and the Washington State Auditor for stand-alone proprietary funds, user fee revenue is not recognized in the financial statements until it has become both earned and available. Although the Operator invoiced \$2,313,704 in 1Q 2024 user fees and collected \$998,754 in payments in 2023, these amounts are not recognized as they do not meet the earned and available criteria. It should be noted that the Cash and Cash Equivalents amount summarized in Table 1 does not include the cash collected for user fees in 2023.

Operating expenses in the amount of \$2,207,030 were recorded for the 2023 fiscal year. This mostly consists of one-time start-up expenditures that were paid for using Start-up funding transferred to the Operator in September 2022.

Non-operating revenues in the amount of \$149,905,908 were reported as of December 31, 2023. This is comprised of the Start-Up and Radio Management contract funds as well as \$6.619 M that is set aside for Maloney Powerline Replacement, In-Building Coverage Study and Rate Stabilization, as summarized in Table 1. These funds were transferred from the Project, and total \$7,049,381. Interest on Investments and Miscellaneous Non-Operating Operating revenues in the amount of \$73,676 were recognized. Although no cash was exchanged for the capital assets acquired through the transfer agreement, Capital Contributions equaling the value of the capital assets is recorded as a non-operating revenue.

Non-operating revenues were provided in the form of start-up funds and were expended on operating activities. There was \$53,197 of non-operating revenue in the form of investment interest.

Title: Capital Projects and Expenditure Requirements

#### **SUMMARY:**

This report discusses the PSERN capital projects and expenditures for 2024 and provides a preliminary estimate of capital expenditure requirements for 2025-2029. Approval is requested to proceed with the procurement activities required for the 2024 projects. It is noted that a determination needs to be made as to whether 2024 repair costs for the Maloney/Sobieski powerline can be funded using surplus levy funds transferred to the PSERN Operator.

#### **BACKGROUND:**

The PSERN Operator Interlocal Cooperation Agreement (ILA) includes a Cost Allocation Model (Exhibit A) that describes how PSERN operating expenses will be split between radios and dispatch consoles. Subsequent work by the PSERN Operator Board of Directors and staff during 2022 and 2023 further clarified how various types of operating expenses will contribute to the calculation of PSERN service fee rates.

The ILA Cost Allocation Model makes no provision for ongoing capital expenditures after Full System Acceptance and transfer to the PSERN Operator. Therefore, any additional capital expenditures will require sources of funding outside of PSERN service fees.

At its March 2024 meeting, the PSERN Project Joint Board approved the transfer of remaining PSERN levy funds (estimated as between \$7.7M and \$8.7M) to the PSERN Operator according to the following schedule:

- May 2024 \$1.2M for expenses in 2024
- November 2024 All but \$1M of available balance (\$6.7 \$7.7M)
- December 2027 (or earlier) Remaining levy proceeds (~\$1M)

Use of these funds must be consistent with the PSERN levy ordinance, which limits them to be used for capital and certain other one-time transition expenses.

PSERN Operator staff have identified several capital projects or purchases that need to be completed in 2024. Staff have also developed a very preliminary forecast of capital replacement requirements over the subsequent 5 years – 2025 to 2029.

It should be noted that pursuant to PSERN's Capital Asset Policy states that any tangible, non-consumable item valued more than \$5,000 with a life expectancy over one year is a capital asset. The policy also defines multiple capital asset classes ranging from 3 to 25 years.

#### **DISCUSSION/ANALYSIS:**

A discussion of the capital expenditures required in 2024 and a forecast for the subsequent years is provided

below.

### 1. 2024 Capital Projects

#### Sobieski & Maloney Power Reconfiguration

PSERN has two radio sites in the Highway 2 corridor near the Town of Skykomish. The two sites are approximately one mile apart – the lower site on Maloney Ridge and the upper site near the top of Sobieski Mountain, at approximately 5000 ft. elevation. The two sites provide redundant microwave connectivity to all additional sites in the Highway 2 corridor. Both are served by a private underground power line, dating to the 1970's and owned by Puget Sound Energy (PSE), that is unreliable and slated for replacement in approximately 2026<sup>1</sup>, although this timing is not confirmed.

Due to the unreliability of the power line, PSERN has temporarily installed additional generators and fuel tanks at Sobieski and is regularly operating both sites on generator power while the powerline is inoperable. The generator and switching configurations were modified after the PSERN site was designed and built but has not been optimized for sustained operations during extended commercial power outages. Because of these issues and site access challenges in the winter, the sites are prone to service interruptions and has a high time-to-repair, as evidenced by a 3-day service outage experienced at Sobieski in January 2024. The powerline also incurs significant repair costs every year, which are discussed further below.

PSERN will undertake an engineering study in the summer of 2024 to define a set of interim (2024-2026) improvements intended to improve reliability and maintainability of the power supply at both sites and prepare for the implementation of the new powerline in 2026 or beyond. The following activities and improvements will be considered, assessed, and possibly undertaken:

- · Replacement of one or more generators and transfer switches
- Interconnecting the two sites together using segments of the existing powerline
- Assessing fuel storage and supply and refueling arrangements
- Installation of additional monitoring and control equipment

This work will be undertaken in two phases:

- 1. An engineering study to assess, determine and design a preferred set of modifications at both sites.
- 2. Sourcing and implementation of equipment and interconnection changes.

High level estimates of the costs for this work are as follows:

- Engineering study and design \$150K
- Sourcing and implementation \$275K

PSERN has issued a Request for Qualifications (RFQ) for engineering services which closes at the end of April. This procurement will be used to select and contract with an engineering contractor to complete the first phase of work. A supply and implementation contractor will be selected through the Invitation to Bid (ITB) process or Small Works Roster process defined in PSERN's Procurement Policy.

The objective is to complete both phases of work before the sites become inaccessible in the late fall of 2024.

<sup>&</sup>lt;sup>1</sup> \$3M of PSERN levy funds have been transferred to the PSERN Operator to cover its share of the powerline replacement. However, it is expected that the actual costs will be significantly higher.

#### Sobieski Building Dormer Removal

The equipment shelter at Sobieski was designed and constructed with a dormer above the entrance door. The dormer has been damaged due to heavy snow loads during recent winters and has required multiple repairs. The long-term solution is the permanent removal of the dormer and associated changes to the roof and its structure.

PSERN already has design and construction drawings for this work. As this is Public Works, procurement will involve either the Invitation to Bid (ITB) or Small Works Roster process.

A high-level estimate of the cost of this work is as follows:

#### Material and construction - \$75K

As with the power system reconfiguration at Sobieski, the objective is to complete the work before the site becomes inaccessible in the late fall of 2024.

#### Existing Sobieski/Maloney Powerline Repairs (PSE)

As discussed above, the existing private power line serving Sobieski and Maloney, owned by Puget Sound Energy (PSE), has required significant repairs every year to restore service after outages. Until the end of 2023, repair costs were split 50-50 between KCERCS and the PSERN Project. In 2024, these costs will be the responsibility of the PSERN Operator.

PSE will invoice the 2024 costs in early 2025 and PSERN's share is currently estimated as follows:

#### 2024 Sobieski/Maloney power line repair – \$200K

PSERN's obligation to pay a share of the powerline maintenance and repairs is defined in a service agreement between PSE and all radio communications operators at the two sites. As these costs are not capital, a determination will have to be made as to whether they qualify under the category of "Transition Costs" as defined in the levy ordinance. If they do not, then the costs will have to be included in PSERN's operating expenses for 2024, or possibly 2025. This is one example of the need for an operating reserve.

#### **Grass Mountain Tower Repairs**

Over the previous two winters, snow and ice loading on the Grass Mountain tower has caused damage to multiple structural components. PSERN has received an estimate of costs to replace the affected components. A determination will need to be made to determine whether the Small Works Roster or ITB process should be used.

A high-level estimate of the cost of this work is as follows:

#### Material and construction - \$200K

This work also needs to be completed prior to the fall of 2024.

#### **Vehicle Purchases**

PSERN acquired 8 light trucks from King County as part of the Transfer Agreement. These vehicles are primarily used by Field Service Technicians to access radio sites and other work locations. Two of these vehicles are at the end of their operational life and will need be replaced this year.

The estimated cost, including costs to outfit with specialized equipment (winches, canopies, storage and

recover equipment) is as follows:

## • Two F250/F350 pickups - \$180K

These vehicles and the specialized equipment will be sourced either via a state contract or through use of the MRSC Vendor Rosters.

#### Summary of 2024 Expenses

The costs discussed above are summarized in the table below. At this point, it is assumed that all these costs qualify either as capital or transition costs such that use of PSERN levy funds is allowed, as defined in the levy ordinance.

Approval to proceed with procurement activities for these projects is being requested. Once procurement has completed and costs firmed up, each project will be brought back to the board for approval to proceed with implementation and expenditures.

# 2. 2025-2029 Capital Requirements

Ongoing capital expenditures will be required after 2024. This is primarily to cover costs of replacing assets that have short life cycles, such as generators that run on a 24X7 basis and vehicles, or for minor capital additions. The final cost of the Maloney/Sobieski powerline replacement in 2026 is expected to be more than the \$3M that has already been set aside for this project.

A preliminary estimate of these costs for 2025-2029 is provided in the table below.

As the costs and timing are better understood, further information will be brought to the board. This estimate will also be discussed when the PSERN 2025 budget is presented, although it should be noted that capital expenses do not affect the PSERN service fee calculations.

#### RECOMMENDATION:

It is requested and recommended that the Board authorize the Executive Director to proceed with procurement activities for the 2024 capital projects listed above. Procurement will comply with the PSERN Operator Procurement Policy — either ITB or Small Works Roster based for Small Works, and use of a state contract or MRSC Vendor roster for vehicle purchases.

Once procurement has completed and costs firmed up, each project will be brought back to the board for approval to proceed with implementation and expenditures.

Further investigation will be undertaken to determine whether the extraordinary repair costs for the Maloney/Sobieski powerline in 2024 can be funded by surplus levy funds transferred to the Operator. If it is determined that levy funds cannot be used, the repair will need to be paid for out of operating funds.

It is recommended that the Board of Directors approve the following motion:

**MOTION**: That the PSERN Operator Board authorize the Executive Director to proceed with procurement activities for the 2024 capital projects discussed in this report.

#### **CONCLUSION:**

This report has discussed the PSERN capital projects and expenditures for 2024 and provided a preliminary estimate of capital expenditure requirements for 2025-2029. Title: Radio Site Sublease Overview

#### **SUMMARY:**

This report provides an update on sub-leases at PSERN radio sites. A summary of the existing and potential future subleases, and the associated sub-lease revenue is provided. This report also highlights that an error in determining the revenue for one of the subleases in the 2024 operating budget.

#### **BACKGROUND:**

A staff report on radio site subleasing was discussed at the May 2023 Board meeting. That report provided an overview of the opportunity for the PSERN Operator to enter into new sublease agreements with wireless network operators to provide access to its towers and other radio site facilities. It also discussed work underway to develop sublease agreements with two national wireless carriers that would be targeted for execution and implementation after FSA.

Over the past year, PSERN staff and legal counsel have developed a template for new subleases to be executed by the PSERN Operator. Discussions and interaction with several prospective tenants have taken place. Typically, this process involves the prospective tenant (i.e. a wireless carrier) contacting PSERN's Facilities Manager directly or submitting a request via email to <a href="mailto:info@psern.org">info@psern.org</a>.

Once contact is made and assuming sufficient interest, the prospective tenant is requested make an application and submit a \$2500 application fee. This fee covers PSERN staff time to enable the tenant to conduct a site visit and perform any other technical and operational due diligence related to their proposed equipment installation at PSERN's site. Prospective tenants are responsible for all costs associated with their application and evaluation of the site, including legal costs to draft a sub-lease and engineering costs to conduct any tower structural analysis that may be required.

Sub-leases typically incorporate a 5-year term and include multiple options (up to 3) for renewal. Sub-lease agreements include an annual escalation factor in the 3-4% range or tied to CPI. Once a sub-lease has been executed and the tenant's equipment installed at one of PSERN's, very little ongoing operational support or effort is needed from PSERN to maintain the revenue stream. Ongoing expense is limited to administrative staff time to prepare invoices and book revenue. From that perspective, sub-leases will generate "passive" revenue.

#### **DISCUSSION/ANALYSIS:**

To date, this sub-leasing process has resulted in 2 new sub-leases being executed since January 2024, with another 11 in process. These are listed in the sections below.

#### 1. List of Currently Active Sub-Leases

Table 1 below lists the sub-leases that are currently active. This includes leases that were transferred from King County as part of the Transfer Agreement (shown in green) and new sub-leases (shown in red).

Note 2 – The rent (\$6365 in 2024) for the WSP lease at Sobieski was incorrectly shown as monthly in the 2024 budget and 2025 forecast.

A total of \$583,836 in sub-lease revenue is included in PSERN's 2024 operating budget. This is shown as an offset to lease expense. Because of the error noted above, this view currently shows a shortfall in sub-lease revenue projected for 2025. This forecast will be updated prior to finalizing the 2025 budget to capture any new sub-leases executed prior that that point.

It should also be noted that the amount of rent charged to each carrier at each site is determined based on the number and size of antennas to be installed on PSERN's tower. In some cases, arrangements have been with other public agencies to waive rent payments where a "quid pro quo" situation exists, i.e. PSERN has antennas on the agency's facilities at other sites and neither charges the other rent. These sub-leases are not shown in the table above.

In the case of the Federal Way site, PSERN's lease requires it to pay 50% of any sub-lease revenue earned to the lessor - South King Fire — as shown in the table above.

#### 2. List of Potential New Sub-Leases

Table 2 below lists potential sub-leases where an application has already been submitted (including the \$2500 application fee) and PSERN is actively working with the prospective tenants to assess the suitability of PSERN's site and draft a sub-lease agreement.

The table shows that the biggest revenue opportunity is with the national wireless carriers (T-Mobile, Verizon, Dish Networks) because of the large number and size of antennas they require.

Any of these potential new sub-leases that get executed prior to June 2024 will be included in PSERN's 2025 operating budget.

PSERN continues to receive additional inquiries related to new sub-leases. It typically takes 6-9 months for an initial inquiry to develop into an executed lease, with commencement of rent payments following several months after that.

#### **RECOMMENDATION/CONCLUSION:**

This report has provided an update on sub-leases at PSERN radio sites. A summary of the existing and potential future subleases, and the associated sub-lease revenue has been provided.

PSERN will continue to work with prospective tenants to develop additional sub-lease opportunities and will incorporate those revenues into its annual operating budgets only once sub-leases have been executed.

Title: Update on Subleases at PSERN Radio Sites

#### **SUMMARY:**

This report provides an update on the opportunity for the PSERN Operator to enter into sublease agreements with wireless network operators to provide access to its towers and other facilities at its radio sites. PSERN continues to receive enquiries from various organizations interested in collocating at PSERN sites and is taking initial steps to prepare for the future execution of subleases by the PSERN Operator in 2024 after Full System Acceptance.

#### **BACKGROUND:**

#### March 2022 PSERN Operator Board - Staff Report

At the March 2022 PSERN Operator Board meeting, a staff report was presented which discussed the opportunity for additional subleases at PSERN radio sites (see Appendix A). The following is a summary of the matters discussed in that report:

- A significant number of radio site subleases will be assigned by the County to the PSERN Operator, so
  the PSERN Operator needs to dedicate resources and budget to ongoing management of its lease and
  sublease portfolio.
- A national wireless carrier has requested PSERN consider new subleases at several sites, and there
  appears to be additional opportunities to initiate agreements with other commercial providers and
  public safety/public service agencies.
- The amount of potential revenue is unknown at this time and will depend on several factors, including wireless provider coverage requirements, market availability, timing and location.
- PSERN Operator policy considerations will need to be further discussed and considered.

In discussing the March 2022 report, Board members expressed reservations regarding both staff and Board capacity, as actively promoting and responding to sublease opportunities could require a great deal of time and resources. It was therefore suggested that work on this could be deferred until the project successfully reaches FSA and in a timely manner.

In response, the Executive Director indicated the Operator intends to target implementing/executing new subleases after radio site assets are transferred to the Operator at FSA. There is no plan to proactively seek or execute subleases prior to FSA and the focus will be on the development of commercial sublease template agreements. As this work would take many months, it was recommended that work on template agreements begin as soon as possible.

### **Developments Since March 2022**

Since the March staff report was discussed, FSA has been delayed until December 2023. The PSERN Operator

has already has missed the opportunity to secure additional passive revenue from a wireless carrier at one site due to that delay.

In that time, PSERN has received additional inquiries from Dish Networks, Pano AI, StarTouch Inc, T-Mobile and Verizon Wireless regarding subleasing at four (4) of the new PSERN sites as soon as possible. As noted above, executing such agreements prior to FSA, while King County is still the owner of the PSERN assets, has been investigated and determined to not be possible. However, it is possible to develop the necessary legal documentation prior to FSA to allow the PSERN Operator to start generating revenue immediately after assignment.

In support of this objective, PSERN staff, in consulation with the PAO and external legal counsel (Busch Law Firm PLLC) have begun to review applications, draft Right of Entry agreements (to allow potential tenants to evaluate the suitability of PSERN sites) and prepare sublease agreements that would become effective upon the transfer of network assets

The goal of this work is put PSERN in the position of sublease execution immediately after FSA in January 2024, with site implementation to occur later in the spring of 2024. T-Mobile and Verizon are aware of these constraints and the expected timing.

#### **DISCUSSION/ANALYSIS:**

The March 2022 report is attached as Attachment 1. It discussed several issues, including the size of the opportunity and policy considerations for the PSERN Operator. The situation regarding these issues has not changed substantively. In particular, the total size of the opportunity is still not fully known as PSERN has not been proactively seeking sublease agreements up to this point.

The remaining discussion in the March report related to the impacts on the PSERN Project and Operator and what should be done to keep this opportunity moving forward.

Developing agreements for subleasing at radio sites and responding to near-term requests from wireless carriers requires the following:

- PSERN staff, supported by Busch Law Firm PLLC will undertake the development of a template agreement for commercial wireless network providers.
- The PSERN Project Site Development Supervisor will consider and assess the technical impact of the requests from prospective tenants (including T-Mobile and Verizon) for installations at the sites they have identified.

A template agreement is being developed and will be used as a starting point for the agreements at each site. It will contain standard (boilerplate) legal, business, technical and operational language that would be modified to suit the specific situation at each site. Because specific requirements can vary significantly between sites, it is not feasible to draft a "master agreement" that would apply to multiple sites.

The effort and costs associated with this work can be accommodated within the existing Project resourcing and budget. PSERN Operator staff will participate in the process of developing the site-specific agreements with the goal of executing them shortly after FSA in January 2024 and completing implementation and commencement of revenue by the Spring of 2024.

Provision is being made in the PSERN Operator 2024 budget for a staff position (Facility Manager) to manage the existing sublease portfolio. As radio site subleasing becomes an expanded service offering for the PSERN Operator, any incremental costs, including additional legal expenses, for this work will be funded out of

sublease revenues. These additional revenues can be considered to be "passive", in that additional costs will be small in comparison to the additional revenue that will be generated. However, no additional sublease revenue will be incorporated into the PSERN Operator's budgets (including 2024) until sublease agreements are executed.

As these initial agreements are developed, the following policy and technical matters will be addressed on a site-by-site basis by PSERN Project and Operator staff and incorporated into an overarching set of guidelines:

- Procedures and processes for responding to subleasing requests, including site access
- Criteria for determining eligibility for subleasing on PSERN sites, including priority and method for allocation of tower capacity and ground/building space
- Method of determining sublease fees/rates
- Technical, operational and security requirements, although many of these have already been defined by the PSERN Project during radio site development

The Board will be requested to approve all sublease agreements prior to execution and will be consulted and/or advised on any policy matters that arise during the drafting and negotiation phase.

#### **CONCLUSION:**

This report has provided an update on the opportunity for the PSERN Operator to enter into new sublease agreements with wireless network operators to provide access to its towers and other radio site facilities. Work is currently underway to develop sublease agreements with two national wireless carriers that will be targeted for execution and implementation in early 2024, after FSA.
